

POPULATION

Lincoln County is located in the central portion of eastern Washington State. In 2018, Lincoln County was the thirtyseventh most populous county in the state with 10,810 individuals. This accounted for less than 1% of the state's population. The population is split evenly with 50% living in Incorporated Lincoln and the other 50% living in the Unincorporated county, with the city of Davenport making up the most populous area (16%). Of the 39 counties in Washington State, Lincoln County had the third lowest population density with a density of 4.68 individuals per square mile. The Washington State density for all counties was 111.77 individuals per square mile.¹

In 2017, adults ages 20-34 made up the smallest proportion of Lincoln County's population. Lincoln County had smaller proportions of adults ages 20-34 and higher proportions of seniors ages 65 years or older than Washington State.

According to 2017 data, Lincoln County was not racially diverse. Among county residents, 94.8% were white, 2.4% were of two or more races, 1.8% were American Indian/ Alaska Native, while all other groups made up less than 1% of the population. Hispanics comprised 2.9% of the population, far lower than the statewide population with 12.8% identifying as Hispanic. Hispanics are included in all race categories.




Distribution of Population by Age and Sex, Lincoln County, 2017



Among students who began ninth grade, 93.6% graduated from high school on time during the 2016/2017 school year. Another 3.2% continued high school beyond the traditional graduation date and completed high school in an extended period. Statewide, 79.3% of students graduated on time. Since the 2010/2011 school year, Lincoln County has had higher on-time graduation rates than Washington.

On-Time High School Graduation





HEALTH INSURANCE AND DISABILITY

For the 2012-2016 U.S. Census Bureau's American Community Survey estimate period, approximately 8.7% of Lincoln County's population was uninsured. The uninsured rate significantly decreased since 2009-2013, from 12.4% to 8.7%, likely reflecting the enactment of the Affordable Care Act. Those who were 18 to 34 years of age, male, American Indian and Alaska Native alone had the highest proportion of being uninsured in their respective demographic categories. The uninsured rate in Lincoln County was lower than Washington State.

In Lincoln County for the 2012-2016 ACS estimate period, 20% of the population had a disability. Disability includes those with hearing, vision, cognitive, ambulatory, self-care, or independent living difficulties. Among those with a disability, 49% were 75 years of age or older. Overall, Lincoln County had higher disability rates than the state.

INCOME AND POVERTY

Estimates of median household income were based on the U.S. Census Bureau's American Community Survey (ACS) estimates for 2006-2015 and census data from 2000. These model-based estimates may differ from other median household income data developed from the Washington State Office of Financial Management's State Population Survey, Bureau of the Census estimates, or other sources.

The projected median household income in Lincoln County for 2017 was \$55,234, compared to \$68,550 statewide. The median household income has been increasing since 2010. For 2012 to 2016, approximately 19.2% of individuals in the county lived below 125% federal poverty level (FPL), and 31.9% lived below 200% FPL. The proportion of Lincoln County residents living in poverty (below 200% FPL) was higher than the statewide proportion (29%).



EMPLOYMENT

Of the estimated 4,955 individuals in the civilian labor force in Lincoln County in 2017, there were 4,710 individuals employed. The average unemployment rate in Lincoln County in 2017 was 4.9%, compared to 4.8% in Washington State.²

HOUSING

For the 2012 to 2016 ACS estimate period, there were an estimated 5,837 housing units in Lincoln County. Of those, 25.7% were vacant. The majority of occupied housing were owner-occupied (78.2%) while the remaining housing units (21.8%) were renter-occupied. The homeowner vacancy rate was 2.5%, while the rental vacancy rate was 7.6% during this period.

The proportion of occupied housing lacking complete plumbing facilities was slightly higher in Lincoln County compared to Washington State. In Lincoln County, 1% of occupied housing lacked complete plumbing facilities and 0.5% lacked complete kitchen facilities. This is compared to only 0.4% of occupied housing in Washington State lacking complete plumbing facilities and 1% of occupied housing lacking complete kitchen facilities.³

In 2017, the median price of homes in Lincoln County was \$105,000 compared to \$348,900 in Washington State. Estimates of median home prices vary greatly in smaller areas. The median price of home sales in Lincoln County varied between \$67,500 to \$105,000 between 2012 and 2017. Housing affordability slightly decreased in both Lincoln County and Washington State. Housing affordability was estimated based on the National Association of Realtors' Housing Affordability Index, defined as the ability of a middle-income family to carry the mortgage payments on a median price home. Housing was consistently more affordable in Lincoln County than Washington State.⁴



Year Housing Units were Built, 2012-2016





Age of Housing Stock, 2012-2016


