


POPULATION

Adams County is located in the central portion of eastern Washington State. In 2021, Adams County was the thirty-first most populous county in the state with 21,100 individuals. This accounted for less than 1% of the state's population. The largest city in Adams County is Othello with a population of 8,920, or 42.3% of the county's total population. Ritzville is the second largest city with a population of 1,780. Of the 39 counties in Washington State, Adams County had the eighth lowest population density with a density of 10.86 individuals per square mile. The Washington State density for all counties was 116.88 individuals per square mile.¹

In 2021, seniors 65+ made up the smallest proportion of Adams County's population. Adams County had larger proportions of children ages 0-19 and smaller proportions of seniors ages 65 years or older than Washington State.

According to 2021 data, Adams County was not racially diverse. Among county residents, 32.6% were white, 1.2% were of two or more races, while all other groups made up less than 1% of the population. Hispanics comprised 64.6% of the population, much higher than the statewide population with 14.2% identifying as Hispanic. Hispanics are included in all race categories.









HEALTH INSURANCE AND DISABILITY

For the 2016-2020 American Community Survey (ACS) estimate period, approximately 15.9% of Adams County's population was uninsured. Those who were 19 to 64 years of age, male, and American Indian and Alaskan Native alone had the highest proportion of being uninsured in their respective demographic categories. The uninsured rate in Adams County was higher than Washington State.

In Adams County for the 2016-2020 ACS estimate period, 11.8% of the population had a disability. Disability includes those with hearing, vision, cognitive, ambulatory, selfcare, or independent living difficulties. Among those with a disability, 56.1% were 75 years of age or older. Overall, Adams County had lower disability rates than the state.

INCOME AND POVERTY

Estimates of median household income were based on the U.S. Census Bureau's American Community Survey (ACS) estimates for 2016-2020 and the Washington State Office of Financial Management from 2021.

The projected median household income in Adams County for 2021 was \$59,463, compared to \$81,998 statewide. The median household income has been increasing since 2017. For 2016 to 2020, approximately 26.3% of individuals in the county lived below 125% federal poverty level (FPL), and 47.6% lived below 200% FPL. The proportion of Adams County residents living in poverty (below 200% FPL) was significantly higher than the statewide proportion (24.1%).



EMPLOYMENT

Of the estimated 9,524 individuals in the civilian labor force in Adams County in 2021, there were 8,993 individuals employed. The average unemployment rate in Adams in 2021 was 5.6%, compared to 5.2% in Washington State.²

HOUSING

For the 2016 to 2020 American Community Survey (ACS) estimate period, there were an estimated 6,684 housing units in Adams County. Of those, 9.7% were vacant. The majority of occupied housing were owner-occupied (61%) while the remaining housing units (39%) were renter-occupied. The homeowner vacancy rate was 2.6%, while the rental vacancy rate was 5.5% during this period.

The proportion of occupied housing lacking complete kitchen facilities was slightly higher in Adams County compared to Washington State. In Adams County, 0.3% of occupied housing lacked complete plumbing facilities and 1.2% lacked complete kitchen facilities. This is compared to 0.4% of occupied housing in Washington State lacking complete plumbing facilities and 1.1% of occupied housing lacking complete kitchen facilities.³

In 2022 Quarter 1, the median price of homes in Adams County was \$263,900, compared to \$563,600 in Washington State. Estimates of median home prices vary greatly in smaller areas. The median price of home sales in Adams County varied between \$183,300 to \$295,800 between 2020 and 2022. Housing affordability slightly increased in Adams County and decreased in Washington State. Housing affordability was estimated based on the National Association of Realtors' Housing Affordability Index, defined as the ability of a middle-income family to carry the mortgage payments on a median price home. Housing was consistently more affordable in Adams County than Washington State.⁴






Age of Housing Stock


