

#### **Population**

Spokane County is located along the central portion of the eastern edge of Washington state. Spokane County was the fourth most populous county in the state in 2021 with 542,100 individuals.¹ This accounts for 7.0% of the state's population. The City of Spokane was the second most populous incorporated city in the state with 229,400 individuals. The City of Spokane accounts for 42.3% of the county population with another 28.2% living in other incorporated municipalities and 29.4% living in unincorporated areas in Spokane County. Spokane County has the eighth highest population density in the state (out of 39 counties) with a density of 307 individuals per square mile.

In 2021, seniors made up the smallest proportion of the population. Spokane County had similar proportions by age


group to the statewide proportions. Over the last decade, the proportion of the population younger than 18 years of age decreased 1.3%. The proportion of the population aged 65 years or older increased 5.3%.

Spokane County is not racially diverse. Among county residents in 2021, 84.3% were white, 8.5% were of two or more races, 2.5% Asian, 2.2% Black, 1.7% American Indian/ Alaska Native, 0.9% Native Hawaiian and other Pacific Islander. Statewide, the population is somewhat more racially diverse. Residents of Hispanic ethnicity comprised 6.9% (37,562) of the Spokane County population and 14.2% of the statewide population. Hispanics are included in all race categories in the following table.





#### **High School Completion in Spokane County**

Among students who began ninth grade, 82.7% graduated from high school on time during the 2020/2021 school year. Another 9.3% of this class continued in high school beyond the traditional graduation date. Statewide, 82.5% of students graduated on time. Both Spokane County and Washington state had a decrease in on-time graduation from high school from the 2019/2020 school year. More information about the education system and student performance is available from the Washington State Office of Superintendent of Public Instruction.<sup>2</sup>

### **Health Insurance and Disability**

In Spokane County, 4.6% of the population is uninsured. Among Spokane County residents, those who are 19 to 64 years of age (6.7%), male (5.7%), and American Indian/ Alaska Native (21%) represent the highest proportion of being uninsured in their respective demographic category. The uninsured rate is lower in Spokane County compared to the statewide population.

In Spokane County, 16.3% of the population are persons with a disability. Disability includes those with hearing, vision, cognitive, ambulatory, self-care, or independent living difficulties. Among those with a disability, 49.6% were 75 years of age or older. Compared to the statewide population, Spokane County has higher disability rates for all ages.

Figure 5. Uninsured Rate Over Time



## **Income and Poverty**

The projected median household income in Spokane County for 2021 was \$61,690, compared to \$81,998 statewide. The projected 2021 median household shows a slight increase from 2020. In 2021, approximately one in six individuals (16.9%) in the county lived below 125% Federal Poverty Level (FPL) and 28% lived below 200% FPL. The proportion of Spokane County residents living in poverty (below 200% FPL) was significantly higher than the statewide proportion (22.6%).

## **Employment**

There were 271,074 individuals 16 years of age or older who were in the labor force in Spokane County in 2021. Of them, 6.3% were unemployed, 1.2% were in the armed forces, and the remaining 93.7% were employed in other occupations.<sup>3</sup> Statewide, the workforce employment was similar; 5.9% unemployed, 1.6% in the armed forces, and 94.1% employed in other occupations. Unemployed individuals are defined as individuals who used an active method of looking for work in the last four weeks, and do not include those who are retired, disabled, or students.

Among the civilian labor force, more than three-quarters were private wage and salary workers (79.4%). Government workers accounted for 15.7% of the labor force and 4.8% were self-employed.

#### **Cost of Basic Needs**

SRHD updated the cost of basic needs information because poverty remains a concern in our community. *The Self-Sufficiency Standard for Washington State* (2020) published by The Workforce Development Council of Seattle-King County (WDC), detailed approaches to measuring the cost of basic needs in Spokane County. The cost of basic needs is based on a family of four consisting of two adults and two children, including one preschooler (3-5 years old) and one school-age (6-12 years old). The annual costs of basic needs were \$53,289, which equates to 201% FPL for a household of four in 2021.

**Food costs** were estimated by the U.S. Department of Agriculture<sup>4</sup> and were available by age group and four food plans. This analysis used the low-cost food plan as a sustainable measure of basic food needs and assumed that all meals and snacks were purchased at a store and prepared at home. Food costs for a family of four with a low-cost plan in September 2021 were \$861 per month.

**Utility costs** were a combination of energy and telephone services. Telephone service was based on the best low-cost cell phone plans published in July 2021 by Consumer Reports. The cheapest cell phone plan for two people cost \$100 per month. The retail sales tax was 8.9% in 2021. The telephone costs after tax were about \$109. Energy costs were estimated from Avista Utilities. The average utility costs were \$133 for a family of three to four living in a 1651-2150 square foot home with electric forced air plus air conditioning in the Spokane/Coeur d'Alene area.

**Housing costs** were based on 2021 Fair Market Rent in Spokane County. According to U.S. Department of Housing and Urban Development, the rent for a two-bedroom apartment was \$1,007 per month.<sup>7</sup>

Transportation costs were based on a family having one car and using public transportation. An assumption was made that there was no car payment. Monthly cost for public transportation is assumed at \$60 per month. The cost of gas was calculated for driving 20 miles per day at 20 miles per gallon at \$3.27 per gallon for gasoline in September 2021. The cost for insurance was about \$89 per month based on the average auto insurance costs in Spokane reported by the Insurance Information Institute in 2019.

Childcare costs were reported by Child Care Aware of Washington Family Center. The information reported for Spokane County for childcare cost identifies two children, one pre-school child 2 ½ to 5 years of age and one school age child >6 years of age, in a family of four. The cost for childcare refers to the average rates for a network center. In 2019, the median cost was \$1,485.

**Health insurance** was based on the estimated premium of a family of four (35, 40 years old, and two children) living at 200% FPL insured with the lowest cost plan in 2021, which was the Ambetter Cascade Bronze plan according to the Washington Health Plan Finder.

**Personal and household expenses** were calculated as 10% of the cost per month for basic needs for a family of four in Spokane County.




### Housing

In 2021, there were an estimated 227,895 housing units in Spokane County. Of those, 4.4% were vacant. The majority of occupied housing was owner-occupied (64.2%), while the remaining housing units (35.8%) were renter-occupied. Over the years, the percentage of owner-occupied housing has slightly decreased while the proportion of renter-occupied housing has slightly increased. Most occupied housing had complete plumbing and kitchen facilities; 0.3% lacked plumbing and 0.6% lacked kitchen facilities.

Approximately 26.3% of housing units were built in 2000 or later. Fourteen percent of housing units were built in 1939 or earlier. Spokane County has a higher proportion of older housing compared to Washington state.

The median price of homes in Spokane increased by 44.8% from the last quarter of 2019 (\$276,900) to the last quarter of 2021 (\$401,000), while the median prices of homes statewide increased by 44.3%. Housing affordability has decreased in Spokane County since the last quarter of 2019 and slightly increased statewide. Housing affordability, or the ability of a middle-income family to carry the mortgage payments on a median price home, is estimated based on the Housing Affordability Index.

City of Spokane Community, Housing and Human Services reported that the 2020 one-day count of homeless individuals in Spokane County identified 1,559 individuals, which is a 19% increase from 2019. (The 2021 count was conducted on the sheltered-only population due to COVID-19 concerns.)




